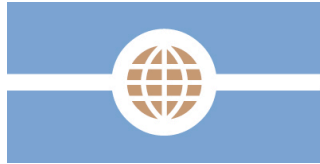

Payment by credit card - credit card Data are collected by the professional third-party service provider Computop and managed for the payment process. The contractor will not receive any credit card information for security reasons.

Payment by direct debit - creditworthiness provided - With your order you give us a direct debit authorization (= SEPA direct debit mandate). The invoice amount will be deducted by us within 14 days after invoicing.

A price adjustment of services of third parties (including consular, visa application center / provider, shipping, invitation fees) may be made at any time during the contract period. Customers will be informed immediately about changes.

The prices are, unless otherwise stated, as net prices. The prices are per traveler and per destination net plus VAT and are valid until further notice.
