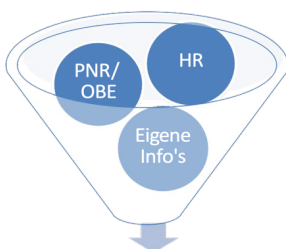

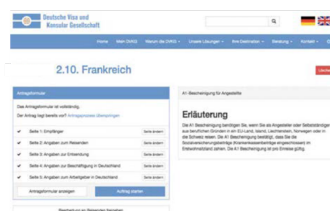

The fees for legalizations / certifications apply plus the respective consular fees, accruing Ghorfa / GLC and BVA fees, as well as the authority, notary and / or translator fees, expense commissions and shipping costs we pay.

Please note that we have to pay up to 65% of the invoice amount in advance (e.g. consular fees, visa application center / provider fees, invitation fees, return shipping fees), and in this context we charge an out-of-pocket fee of 5.4%.

Credit Card Payment - Credit card data is collected and managed for the payment process by the professional third party service provider Computop. The contractor does not receive credit card data for security reasons.

Payment by direct debit - Creditworthiness provided - With your order you give us a direct debit authorization (= SEPA direct debit mandate). The invoice amount will be debited by us within 14 days after invoicing. Direct debits are only possible from a German bank account.

A fee adjustment of third party services (including consular, visa application center/provider, shipping, invitation fees) can be made at any time during the contract period. The client will be informed immediately of any changes.

Fees are net fees unless otherwise stated. Unless otherwise stated, the fees are net per traveler and per destination plus VAT and are valid until revoked.
